21	Project Composition	Can multiple (two or more) overseas research institutions be included?	Yes, it is allowed.
22		What does it mean that the same R&D institution cannot participate redundantly as both lead and co-research institution in one project?	This means that if Institution A is the lead principal institution, it cannot also participate as a co-research institution or subcontractor. In other words, a single institution cannot be duplicated in multiple roles within the same project.
23		Can U.S. government-affiliated researchers (e.g., NIH), U.S. public benefit corporations, or international organizations located in Korea participate as collaborating institutions?	Yes. Any institution that qualifies as a research and development institution under the Framework Act on National R&D Innovation is eligible. Institutions that have previously participated in national R&D projects are generally eligible to apply.
24		Can an overseas institution serve as the lead institution?	No. Only domestic (Korean) institutions can serve as the lead institution.
25		Is personnel exchange between overseas institutions mandatory?	No, it is not a mandatory requirement.
26		What should be entered as the R&D project number?	You should enter the project number assigned during project creation in IRIS (it begins with "RS-").

27	Proposal and Additional Documents	Do I need to submit the 2-1 Master research proposal file and also the 2-2 to 2-4 files?	Yes. Each participating institution must complete its respective proposal form. The lead principal institution should compile and submit the 2-1 Master file as an overview.
28		If the consortium consists of one lead principal institution, one U.S. collaborating institution, and three domestic collaborating institutions, how should the documents be submitted?	For the planning forms, one copy each of Word files 2-2, 2-3, and 2-4 must be prepared per institution. If there are three domestic collaborating institutions, a separate 2-4 file must be prepared for each, resulting in three copies. For example: 2-1 Master (1 copy), 2-2 Lead Institution (1 copy), 2-3 Overseas Collaborating Institution (1 copy), and 2-4 Domestic Collaborating Institutions (3 copies).
29		What is the "List of Representative Previous Publications Related to the Proposed Study"?	It refers to papers, patents, and other publications resulting from prior research relevant to the topic of the current proposal.
30		Does the "References" section count toward the 10-page limit?	No. The "I. Research Plan" section must be within 10 pages, excluding references.
31		For overseas institutions, it may be difficult to obtain an IRB commitment letter with an official seal. Is the IRB commitment letter required at the time of application?	At the time of application, you may submit an "IRB Application Form." If selected, the IRB approval letter must be submitted by the time of agreement signing.
